**OVERVIEW:**

Pentair Electronic Packaging's West Coast Operation in Poway, California, was formerly APW Electronic Solutions, including Birtcher products, founded in 1974. The core competencies are the manufacturing, design and integration of electronic packaging products; including electronic systems, backplanes, front panels, rugged card guides and subracks.

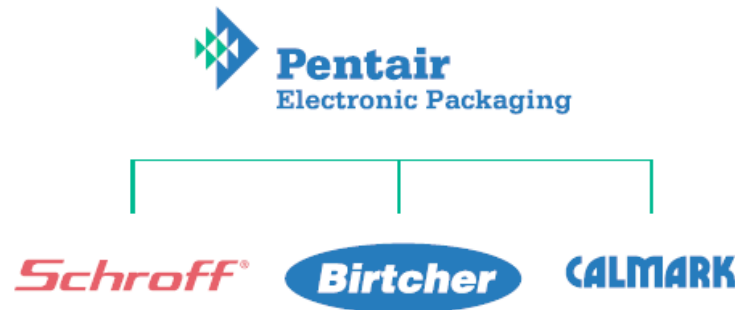


Figure 1: Brand organization:

On May 7, 2007, the company acquired Calmark Corporation. Which has since been integrated into this operation. The company is organized per Figure 1, below where Birtcher, Calmark and Schroff are product brands of Pentair Electronic Packaging.

*Note: the legal entity of this operation is 'PEP West Inc.' but does business as (dba) Pentair Electronic Packaging.*


